- II) The texts must punctually talk about the themes covered by the proposed title of the collective work;
- III) The authors will be entirely responsible for the content of their articles;
- IV) Only 01 (one) work per author is allowed, and co-authorship in the development of the scientific article is perfectly possible;
- V) The articles will be assigned free of charge by their authors, and the signature of copyright assignment letter will be mandatory, according to the model to be opportunely forwarded by the organization of the collective work and present in annex II of this call.

Contain between 15 and 30 pages, following the pattern of letter n. 12, Times New Roman, justified alignment, 5 line spacing and 2 cm paragraph;

Contain an informative summary in the language of the work with at least 100 words;

Contain at least 04 (four) keywords in the language adopted by the author;

4

References must be made in the numerical system, as well as the explanatory notes exposed in the footnote;

SPECIFICATIONS FOR MAKING THE ARTICLE

5

The article must contain an indication of the authors' qualifications and institutional affiliation, and the thematic insertion of the article in the research line of its scientific investigation;

6

Complete works will be received from August 07, 2022 to December 07, 2022, and must be sent in Word format, ending in .doc or .docx, or Libreoffice format to the following emails: bel_toledo13@hotmail.com and pedro.ferreira@uemg.br;

7

Only works that are within the above mentioned standardization rules will be analyzed, as well as properly inserted in the central axis highlighted in the proposal title;

IN ADDITION, THE PUBLICATION OF THE SUBMITTED TEXT DEPENDS ON THE FOLLOWING CRITERIA:

- a) adequate structure;
- b) correct handling of technical language;
- c) clarity and originality in the development of the subject;
- d) theme relevant to the work proposal; and
- e) scientific relevance.

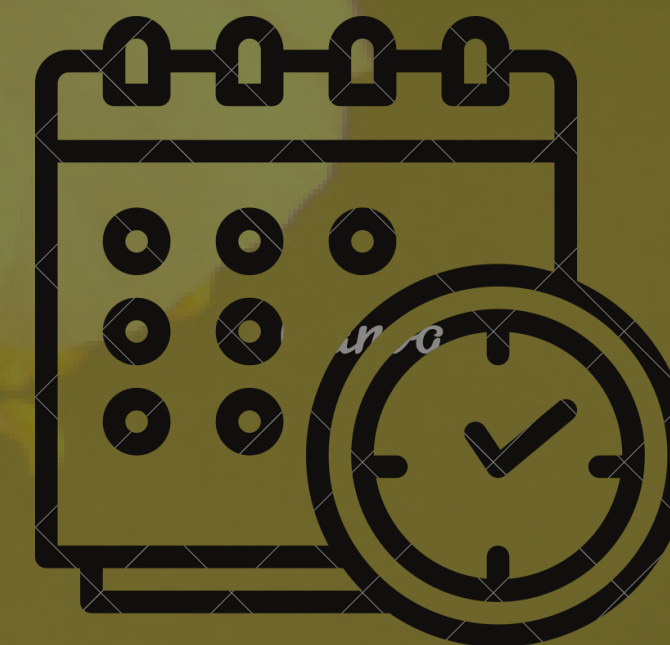
